## FRANKLIN ELEMENTARY SCHOOL

The Bulldog Academy Rules 2022-2023

- 1. Students should report immediately to the after school program when they are dismissed from school.
- 2. All Franklin Elementary School rules apply to the after school program.
- 3. All students must be in supervised areas visible to the teacher or supervisor on duty. Behind buildings, in hallways and in restrooms do not constitute supervised areas.
- 4. Disruptive/defiant behavior (fighting, talking back, inappropriate language, etc.) will not be tolerated. Appropriate consequences will be given based upon our district policy.
- 5. No toys are allowed at the after school program without prior approval of staff. This includes; trading cards, hand held electronic games, portable radios, IPods, cell phones and personal laptops/tablets.
- 6. All students are expected to arrive on time and be picked up no later than 5:30 pm. A \$35 fee will be applied to all late pick-ups.
- 7. Students must attend the regular school day in order to attend the after school program.
- 8. It is expected that students attend the after school program on a regular bases.
- 9. No student will be allowed to leave without being in the company of an authorized person over the age of 18. All persons picking up students must be prepared to show legal identification.
- 10. Tuition is due on the 1<sup>st</sup> of each month. After the 5<sup>th</sup> it is considered late and a \$35 fee will be charged.
- 11. The after school program must be notified if a student will not be attending the after school program.
- 12. In case of an emergency, injury or illness, school personnel will call for emergency services, including paramedics.

I have reviewed the after school program rules with my child and realize that repeated violations could result in suspension of the after school program services.
