The district relies on stakeholder feedback to monitor programs and services as well as guide future planning efforts. ESSER III

Stakeholder groups, including parents/guardians, students, staff, community members, ELAC, and community partners expressed many of the same priorities for ESSER III funds. Priorities include:

- Facility repairs/improvements and improving indoor air quality
- Increasing outdoor learning spaces and eating areas
- Student academic and SEL support (intervention, after-school tutoring, summer school, online intervention programs, and SEL services)
- Enrichment opportunities, GATE classes, field trips, assemblies (storytelling)

As a result of stakeholder input, ESSER III funds will be used as follows:

Safe In-Person Learning: Actions include increasing outdoor seating to lessen close contacts and reduce COVID exposures and replacing additional HVAC units to improve indoor air quality.

Addressing the Impact of Lost Instructional Time: This area was a priority across multiple plans in 2020/21 and remains a priority for all stakeholder groups. Related ESSER III actions include purchasing software, funding staff to provide after-school tutoring and homework help as well as summer school in 2022.

Uses of Remaining Funds: Other areas of focus for stakeholders include funding SEL incentives, an American Indian storytelling assembly, and paying Shady Creek Outdoor Science Camp tuition for our 7th grade students who missed the experience as 6th graders.

ESSER III Expenditure Plan Instructions

Introduction

School districts, county offices of education (COEs), or charter schools, collectively known as local educational agencies (LEAs), that receive Elementary and Secondary School Emergency Relief (ESSER) funds under the American Rescue Plan (ARP) Act, referred to as ESSER III funds, are required to develop a plan for how they will use ESSER III funds to, at a minimum, address students' academic, social, emotional, and mental health needs, as well as the opportunity gaps that existed before, and were exacerbated by, the COVID-19 pandemic.

The plan must be adopted by the local governing board or body of the LEA at a public meeting on or before September 30, 2021 and must be submitted for review and approval within five days of adoption. A charter school must submit its plan to its chartering authority for review and to the COE of the county in which the charter school operates for review and approval.

In addition, consistent with the requirements of the ARP, Volume 86, *Federal Register*, page 21201, April 22, 2021, the ESSER III Expenditure Plan must be:

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.

 - Administering and using high-quality assessments that are valid and reliable, to accurately assess students' academic progress and assist educators in meeting students' academic needs, including through differentiated instruction,
 - Implementing evidence-based activities to meet the comprehensive needs of students,
 - Providing information and assistance to parents and families of how they can effectively support students, including in a distance learning environment, and
 - Tracking student attendance and improving student engagement in distance education;

- School facility repairs and improvements to enable operation of schools to reduce risks of virus transmission and exposure to environmental health hazards, and to support student health needs;

- Inspection, testing, maintenance, repair, replacement, and upgrade projects to improve the indoor air quality in school facilities, including mechanical and nonmechanical heating, ventilation, and air conditioning systems, filtering, purification and other air cleaning, fans, control systems, and window and door replacement;
- Developing strategies and implementing public health protocols including, to the greatest extent practicable, policies in line with guidance from the Centers for Disease Control and Prevention (CDC) for the reopening and operation of school facilities to effectively maintain the health and safety of students, educators, and other staff;
- Other activities that are necessary to maintain the operation of and continuity of services in LEAs and continuing to employ existing staff of the LEA.
